VA announces expanded burial benefits July 10, 2025 - 1:00 pm

WASHINGTON — The Department of Veterans Affairs announced today it has temporarily expanded burial benefits for certain Veterans, per the **Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act.**

The new law specifies eligible Veterans are those who are discharged from VA-provided medical or nursing care to receive VA-provided hospice care at their home and who pass away between July 1, 2025, and Oct. 1, 2026.

Previously, Veterans who died at home under VA hospice care after discharge from VA-provided medical or nursing care were not always eligible for a full VA burial allowance. The Dole Act addresses that gap.

VA is working hard to fully implement the many provisions of the Dole Act," **said VA Secretary Doug Collins.** "We're excited to offer this expanded benefit, which better supports Veterans who choose to spend their final days at home, surrounded by their loved ones."

Families and caregivers of Veterans receiving hospice care at home following discharge from VA-provided medical or nursing care are encouraged to contact their local VA for information about eligibility and how to apply for burial benefits. PROPOSED AMENDMENTS TO FRA LOW COUNTRY BRANCH 269 BYLAWS

The First Reading of the proposed changes to the FRA Branch 269 Bylaws was read at the FRA Branch 269 General Assembly Meeting held on Thursday, July 17, 2025.

The proposed amendments to the FRA Branch 269 Bylaws will be presented and voted on at the FRA Branch 269 General Assembly which will be held on Thursday, August 21, 2025, as follows:

CHANGE 1

Article IX, Section 904: Change this section to reflect Section 904(a) and add a new Section 904(b) to read as follows:

"Article IX, Section 904(b). The Board of Directors may expend a sum of money not to exceed one thousand dollars (\$1,000) periodically for the sole purpose of restocking Branch membership pins and medallions as requested by the Branch Secretary."

CHANGE 2

Amend Article X, Section 1006 relating to Americanism Essay Contest awards to reflect as follows:

"Article X, Section 1006. Americanism Essay Contest awards shall be in the form of gift cards. There shall be up to six Third Place in the amount of \$75.00, six Second Place in the amount of \$100.00, five First Place in the amount of \$200.00, and one overall winner in the amount of \$500.00."

Rationale: In the past the Branch awarded six First Place winners an amount of \$200.00 each and one overall winner an additional amount of \$500.00 for a total of \$700,00 that the overall winner received. This amendment reduces the amount of award money dispensed to Frist Place winners by \$200.00.

CHANGE 3

Amend Article X, Section 1007 relating to Branch officer hat pins by adding a new sentence at the end of the section to read: "These officer hat pins are the property of FRA Low Country Branch 269."

Rationale: In the past the Branch had some officers who refused to return their pins at the end of their tenure in office believing the pins belonged to them. These officer hat pins are quite expensive to replace.

CHANGE 4

Article X, Section 1002 reads: "Any member of the Branch who successfully completes 5, 10, 20, 30, 40, 50, 60, and 70 continuous years in the FRA shall be presented with the applicable pin at a Branch meeting in their anniversary month or mailed to them, if required. Cost of the pins and mailing to be defrayed by the Branch." All remaining portions of the section remain intact.
