Treat your IoT devices like a guest

Our digital world, for better or worse, is expanding at an incredible rate. The Internet of Things (IoT) ecosystem has provided us with many new devices such as smart thermostats, smart doorbells like Ring and Blink, baby monitors, and kitchen appliances. In addition, the IoT of Medical Things (IoTM) ecosystem provides Internet connected devices like wearables, sensors, and smart equipment that collect, share, and analyze health data for real-time monitoring, remote care, and improved efficiency of services. All these devices use computing software of various types, like embedded firmware, or perhaps use an app that performs their function without our intervention. They connect to our home networks to provide their services. And AI now has the potential to pair with, or even replace, these devices for an even more interactive use of the technology. And that my shipmates, is where the trouble can begin.

Many of these IoT and IoTM devices, which are all connected to the Internet in some fashion, often have minimal built-in security, or none at all. This leaves them, your home network, and

your network attached devices like PCs, smartphones, security cameras, and even home medical equipment vulnerable to attack. These cybercriminals can even use breached devices to create botnets for other attacks.

But there is hope. Most all modern Internet access routers and gateways used by Internet Service Providers (ISPs) provide a network feature called the Guest Network. Originally, they were intended to allow your guests to have Internet access while in your home, or place of business. They provide a means to isolate your home or business network from these less secure devices while allowing them the necessary Internet access.

The following article will provide information about the pros and cons of using your router/gateway Guest Network features to isolate these less secure devices in your home:

DID YOU KNOW?? Let's talk Windows!

+++++

Free up space on Windows: Low on storage? Clear out temporary files. Got to **Settings** > **System** > **Storage** > **Temporary files**, check what you don't need, then hit **Remove files**. You might gain back a few gigabytes. FYI: Look inside your **Downloads folder** first. There might be something important in there.

+++++

Turn off sleep mode in Windows 11: Go to **Settings** > **System** > **Power** > **Screen, sleep & hibernation timeouts**. Set **Turn my screen off after**, **Make my device sleep after** and **Make my device hibernate after** all to **Never**. But if you're on a laptop, this will drain the battery when it's not charging.

+++++

Improve laptop performance: Windows 11 intentionally throttles your system to save battery, but you can fix that. Go to **Settings** > **System** > **Power & battery**. Under **Power Mode**, switch both **Plugged in** and **On battery** to **Best Performance**. Your laptop will feel smoother, though it may drain the battery faster when unplugged.

Windows 11 context menu fix: ICYDK, Microsoft hid some features that used to be in the right-click menu for files and folders under **Show more options**. If you want to see everything at once, hold **Shift** and **right-click**, and the full menu will pop up instead.

Veterans Deemed Unable to Care for Themselves

As reported March 11 by Linda F. Hersey for *Stars and Stripes*, attorneys from the VA — under direction from the Justice Department — are initiating legal steps to place veterans deemed incapable of caring for themselves under public guardianship and conservatorship, the agencies announced Wednesday. The Justice Department will begin appointing VA attorneys as special U.S. assistant attorneys to participate in state court proceedings to move the “most vulnerable veterans” under public guardianship after a clinical determination, according to a written statement from the two agencies. The effort will extend to some veterans who are homeless or at risk of homelessness but lack family support or legal representation. They are individuals who’ve demonstrated that they are unable to make their own healthcare decisions, the two agencies said. The federal government will seek guardianship or conservatorship via the state courts, under the terms of a newly signed memorandum of agreement between the VA and DOJ.

The ‘Old Guard’ Marks Centennial of Watching Over Tomb of the Unknown Soldier

As reported March 9 by Claire Barrett for *Military Times*, for over 100 years, Arlington National Cemetery has been the site of the Tomb of the Unknown Soldier, but it hasn’t always been guarded — or revered. Following the soldier’s 1921 internment, the burial site was unguarded and often treated as a tourist attraction by visitors. That is, until 1925, when “concern over the lack of respect led Army Maj. Gen. Fox Conner, the Army’s deputy chief of staff, to order an armed military guard on March 24, 1926.” The first sentinel was posted the very next morning, with units from the 16th Brigade, 8th Infantry Division, 3rd Battalion, 12th Infantry Regiment, and the 2nd Squadron, 3rd Cavalry Regiment, beginning what would become an unbroken vigil. The 3rd U.S. Infantry Regiment, known as “The Old Guard,” was designated as the Army’s official ceremonial unit on April 6, 1948.

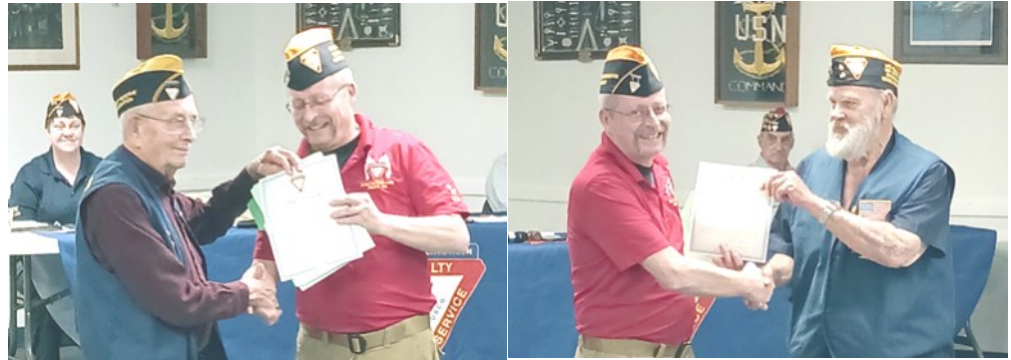
Common government imposter scams affecting Veterans

- Payment redirect/direct deposit fraud: Avoid depositing VA benefits directly into a family member’s or caregiver’s bank account unless they are a court-appointed representative or a VA -accredited fiduciary. This precaution helps to prevent any potential misuse of funds and ensures that benefits are managed by legally authorized individuals.
- Fake compensation claims assistance: Scammers often pose as individuals offering assistance to help file compensation claims or appeals, requiring upfront fees. These imposters typically misappropriate the funds or charge excessive fees for their services, leaving the Veterans worse off financially.
- Pension poaching: Bad actors may offer to manage a Veteran’s pension benefits, promising increased payouts. These scammers often misappropriate the funds or charge excessive fees, which can lead to financial distress for the Veteran.

PRESUMPTIVE SERVICE CONNECTION ELIGIBILITY



WHAT IS PRESUMPTIVE SERVICE CONNECTION?

For some conditions and certain disabilities, VA automatically assumes (or “presumes”) that your service caused your condition. We call these presumptive conditions. This is because of the unique circumstances of a specific Veteran’s military service. If Veterans are diagnosed with a presumptive condition and meet the service requirements for the presumption, then disability compensation may be awarded.

Additionally, when a Veteran’s cause of death is a presumptive condition and the service requirements are met, the Veteran’s surviving spouse, dependent children, or parents may qualify for service-connected death benefits, to include Dependency and Indemnity Compensation (DIC) and burial benefits.

WHAT ARE PRESUMPTIVE CONDITIONS?

Presumptive conditions are established by law or regulation, which provides a link to the Veteran’s military service, reducing the evidentiary burden on the Veteran. These conditions are considered to have been incurred in or aggravated by military service if manifested to a certain severity level within a specific timeframe, if applicable—even if there is no evidence of such disease during military service. Veterans who served in recognized locations during timeframes in which toxic exposure occurred do not need to prove actual exposure or a link between the claimed condition and exposure.

CHRONIC (LONG-LASTING) CONDITIONS

The following chronic conditions are presumptive if the disease manifests in the specified timeframe and the Veteran served continuously for at least 90 days.

- » Lupus erythematosus, systemic
- » Myasthenia gravis
- » Myelitis
- » Myocarditis
- » Nephritis
- » Other organic diseases of the nervous system
- » Osteitis deformans (Paget’s disease)
- » Osteomalacia

OTHER DISEASES

Coronavirus disease (COVID-19) is also subject to presumptive service connection within fourteen days following the date of separation from a qualifying period of service:

- » active duty from March 1, 2020, until January 5, 2024
- » active duty for training (ADT) under Title 10 or full-time National Guard duty (as defined in Section 101 of Title 10) under orders issued on or after March 13, 2020, until January 5, 2024
- » certain periods of inactive duty for training (IADT) during which COVID-19 is presumed to have been incurred occurring between March 13, 2020, and January 5, 2024.

Marine Who Crawled Under Bridge To Plant Explosives Approved For Medal Of Honor

Marine Capt. John Ripley hung 500 pounds of explosives on the underside of a key bridge to stop an enemy offensive. He swung hand-over-hand for three hours while under fire from snipers and tanks.

A Marine who single-handedly destroyed a major bridge in Vietnam, swinging hand-over-hand across its steel girders to plant explosive charges even as an enemy tank fired at him, now appears set to receive the Medal of Honor.

Marine Capt. John Ripley's three-hour, one-man assault on the Dong Ha Bridge in April 1972 has long been a hallowed story in the Marine Corps. Fellow Marines, friends, and advocates have pushed for decades to see the Navy Cross he was awarded for the battle upgraded to a Medal of Honor. Those efforts appear to be nearing success, after the Senate approved special legislation that cleared the way for the award to be presented to him posthumously after his death in 2008

Final approval now falls to President Donald Trump.

A one-man assault

In April 1972, Ripley was a senior advisor to the 3rd Vietnamese Marine Battalion when the unit suddenly found itself in the path of two North Vietnamese Army divisions and a column of tanks in what was later dubbed the Easter Offensive. Ripley was ordered to stop the oncoming force, which was far larger than his own and backed by armor. "Hold and die," were the words passed over the radio.

To do that, he slung explosives around his shoulders and climbed into the steel I-beam girders beneath a key bridge over the Cua Viet River.

"I'm dangling under the bridge and hanging by my arms with a full load of explosives," he told the U.S. Naval Institute. "I would drop down out of the steel, grabbing the flanges of the I-beam; swing sideways, and leap over to hand walk all the way out over the river

From the far bank, the North Vietnamese tried to dislodge him with sniper fire and, eventually, a tank, which fired a round at his spot under the bridge. The round ricocheted and exploded on the riverbank.

"Boy, when that 100mm round went off with me in the steel of the bridge, what a racket," Ripley said in 2008 when he was inducted into the U. S. Army Ranger Hall of Fame. He later credited his knowledge of explosives at Dong Ha to training at the Army's Ranger School.

For more than three hours, Ripley swung hand over hand beneath the bridge, making five trips out over the water. He eventually placed 500 pounds of explosives. To stave off exhaustion, he constantly recited a simple prayer: "Jesus, Mary, get me there;

get me there,” he told The American Society for the Defense of Tradition, Family and Property in a 2008 interview.

Throughout, he later said, he expected to be killed.

“The idea that I would be able even finish the job before the enemy got me was ludicrous,” Ripley said in a 2007 interview with the U.S. Naval Institute in 2007. “When you know you’re not going to make it, a wonderful thing happens: You stop being cluttered by the feeling that you’re going to save your butt.”

After rigging the final blasting caps to a time-fused cord, he hurried off the bridge just moments before it blew, throwing him through the air.

“I’m lying on my back, looking skyward, and I can see enormous chunks of this bridge going through the air,” Ripley told the U.S. Naval Institute. “It was a tremendous feeling.”

The downed bridge created a logjam of North Vietnamese tanks that U.S. bombers and warships were able to hammer. The Easter Offensive failed, and Võ Nguyên Giáp, who had led the Vietnamese communists to victory over the French decades earlier, was replaced as the commander of the North Vietnamese armed forces.

Reconnaissance Marine and college leader

By the time Ripley acted at Dong Ha, he had been through an exhaustive series of top training schools and assignments with elite foreign units.

As a Force Reconnaissance Marine, he graduated from the Army’s Airborne, jumpmaster and Ranger schools, scuba training, and the Marines’ Amphibious Warfare School. After his first tour in Vietnam, he took exchange assignments with the British Royal Marines, attending their Commando Course, and attached with both Singapore Commando brigades and Nepalese Gurkha troops. Ripley also served a tour with the British Special Boat Service, completing Mountain and Arctic Warfare Courses in Norway (later as a senior commander, he took several battalions of Marines to Norway for training).

Only then did he return to Vietnam in 1971.

Ripley retired in 1992 as a colonel. He became the president of a small college in Virginia and served as the Director of Marine Corps History and Museums Division. At the Naval Academy’s Memorial Hall, a diorama depicting Ripley’s action is on display to represent all graduates of the school who fought in Vietnam.
